<b>COMPONENTS</b>	The <b>frame</b> is composed of two parts combined together by a hinge expressly designed for this chair. The two parts are composed of metal tubes, rectangular-section and round metal rods, welded. It can be powder coated with polyester varnish of the following colours: colours: black (M7), white (M6) and aluminium satinated (AL2); aluminium embossed (AL1) (epoxypolyester paint) or chromium plated (CRO).	
	The <b>seat</b> is composed of a chipboard panel, padded with CFC-free polyurethane foam and upholstered.	
	The <b>back</b> is in beech veneered plywood, available with the following finishings: natural beech (T1); ash veneered plywood, available with the following finishings: oak-stained ash (T2), natural ash (T3), white aniline ash (T4), black aniline ash (T5), grey aniline ash (T6) and wengè aniline ash (T8). Wood is water-based varnished.	
<b>ORDINARY CLEANING AND MAINTENANCE</b>	The nylon (PA) <b>gliders</b> are exclusively designed and produced for Pocket chair, allowing stability and avoiding damages on floors where chairs are placed.
